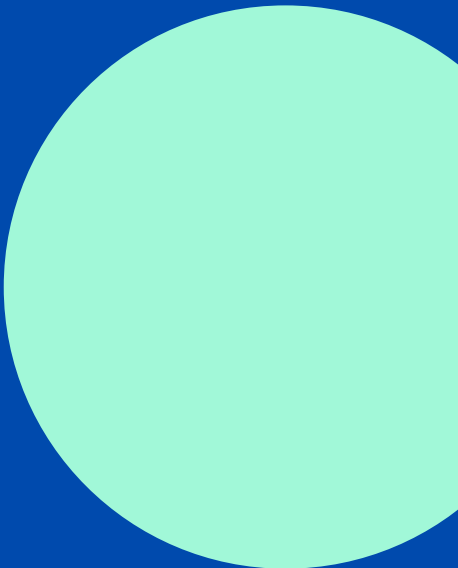
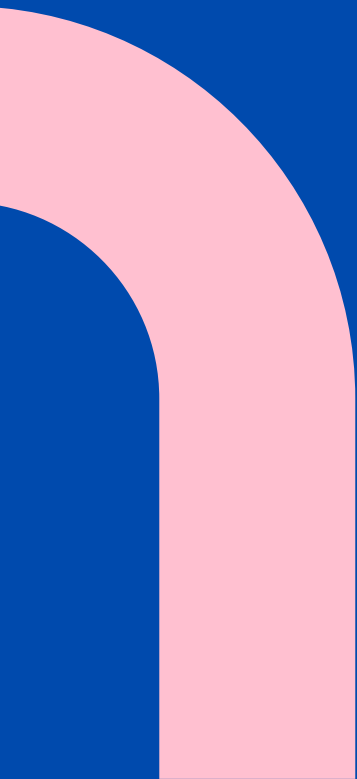
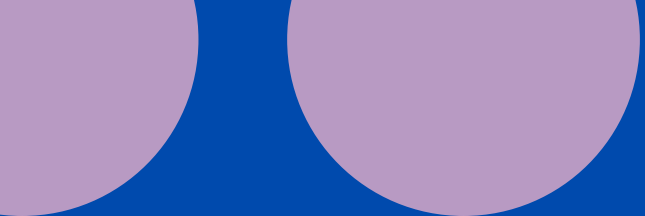

Our 3 ideas

1st

ID Wallet makes **travel easier** by securely **keeping documents** and **payments** in **one place** for quick and **safe** use.

2nd

ID Wallet for **pet owners** simplifies care by securely storing **essential pet details**, enabling quick access for **vet visits**, lost pet recovery, and seamless profile transfers.

3rd

ID Wallet simplifies **global job applications** by securely sharing **verified education** and **employment records** via **QR codes** and **e-apostilles**.

Our proposal

「Simplify administrative processes related to pet ownership by centralizing essential information and payments within a secure ID Wallet for owners」

AllinOne X Onfido

Owner Identity Verification

Uses biometric and document checks to ensure only verified owners can manage pet profiles.

Secure Access for Third Parties

Verifies the identity of individuals (e.g., someone finding a lost pet) via quick selfie or ID checks.

Validated Pet Profiles

Partners with vets and shelters to certify animal data like vaccines and microchip IDs.

Safe Transactions

Adds a security layer for pet ownership transfers and payments to reduce fraud.

B2B Integration

Provides API solutions for vet clinics and shelters to connect securely with the Wallet.

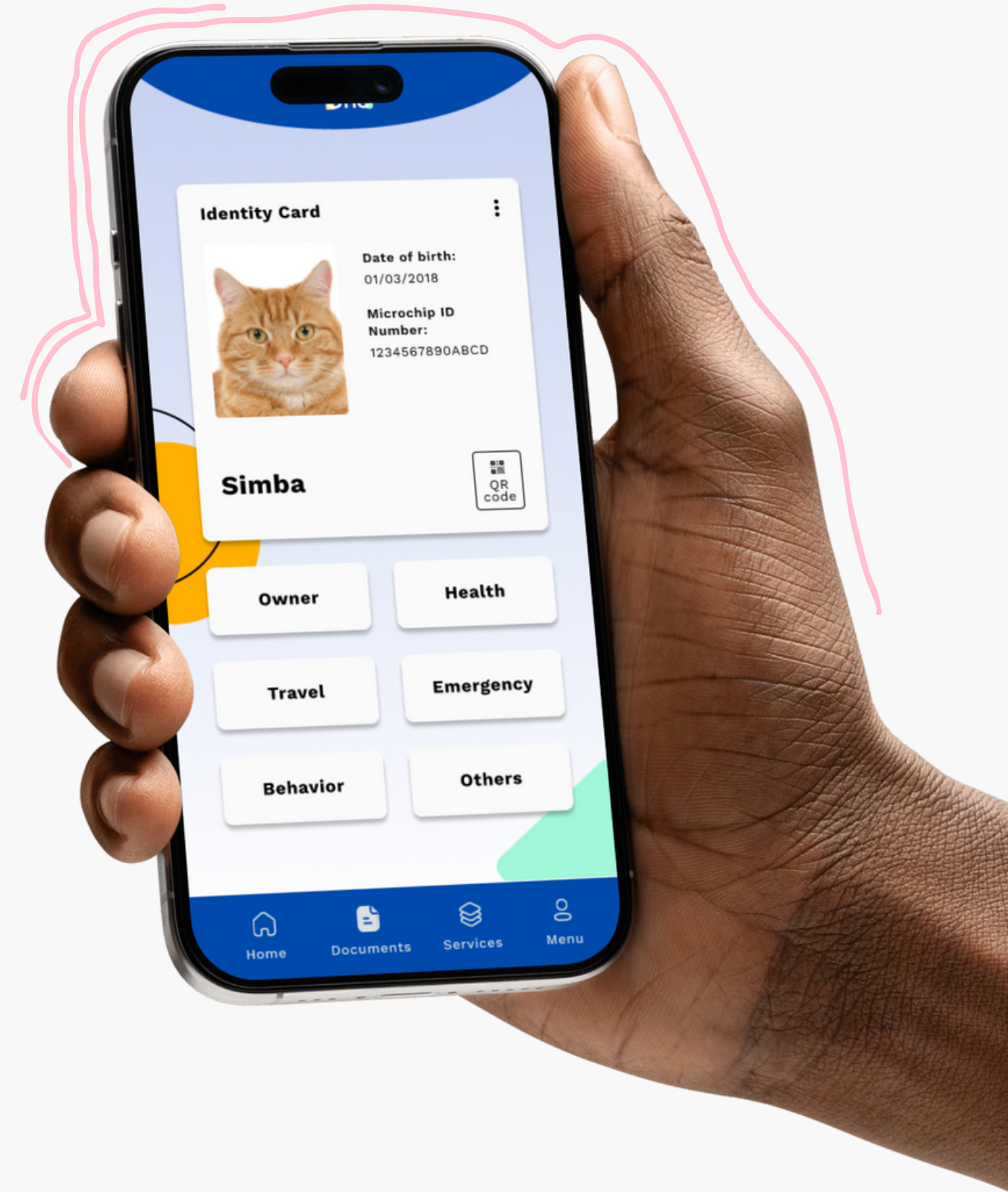
Final Concept

WHAT:

- **Secure digital ID wallet** for pet owners, storing all pet-related information (vaccination history, microchip IDs, emergency contacts, and payment methods) locally on a **protected chip-enabled** card.
- **Ensuring** smoother administrative tasks and travel-related activities for pets, and access on smartphones.

WHY:

- To **simplify travel requirements** such as vaccination documentation
- **Facilitate pet recovery** during lost animal incidents
- **Streamline administrative processes** like booking transportation (e.g., buses, trains, planes) with pets.



Final Concept

WHO:

Pet owners who travel frequently with their pets, as well as those managing pet-related emergencies or adoption/sale processes.

WHEN:

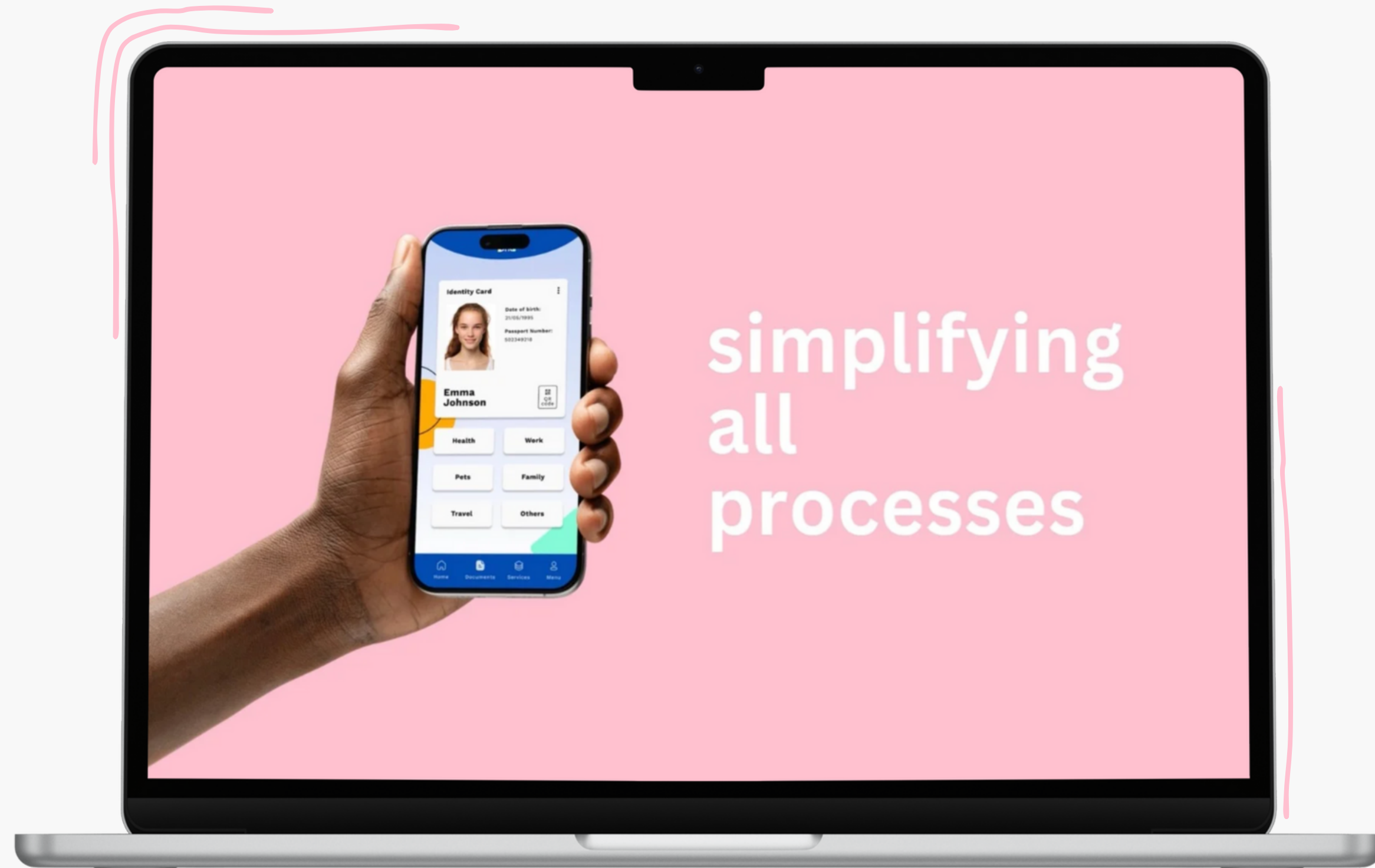
During daily activities such as vet visits, pet recovery situations, and when managing pet adoption or selling processes, especially **in travel settings** like airports, bus stations, and during vaccination requirements.

WHERE:

The wallet is accessible via a **mobile app**, compatible with devices like **smartphones, tablets, and wearable technology**, ensuring convenience during vet visits, travel, and pet recovery scenarios.
